PGY2 residency programs build upon Doctor of Pharmacy (PharmD) education and PGY1 pharmacy residency training to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives for advanced practice areas. Residents who successfully complete PGY2 residency programs are prepared for advanced patient care or other specialized positions, and board certification in the advanced practice area, if available.

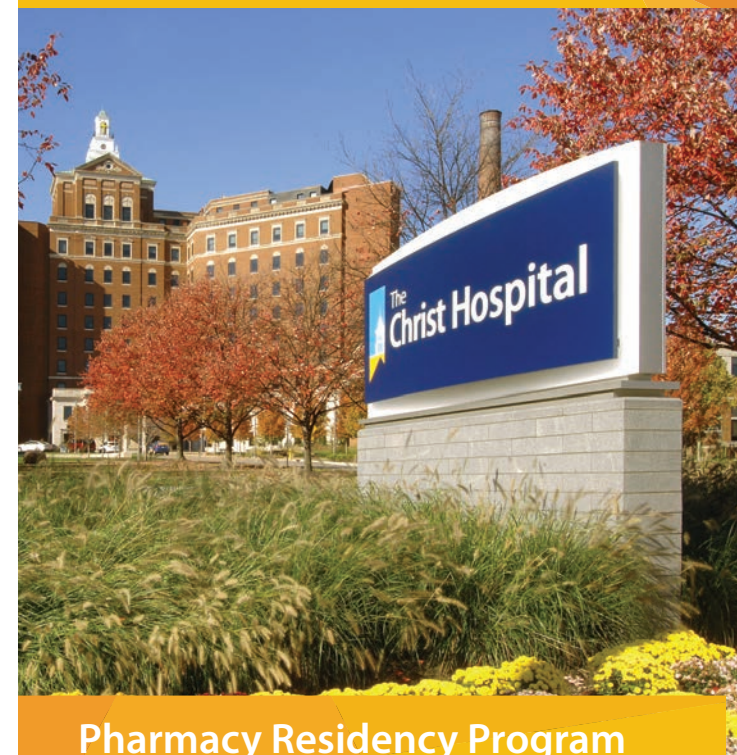

- Graduate of an ACPE-accredited College of Pharmacy with a Doctor of Pharmacy degree
- Participating in or completion of an ASHP-accredited PGY-1 residency or one in the accreditation process
- Eligible for pharmacist licensure in Ohio
- US citizen or legal resident
- Meets criteria for employment at The Christ Hospital, including vaccination requirements and a negative drug and tobacco screen

- Curriculum vitae
- Cover letter/letter of Interest
- Three references
- Additional questions through PhORCAS
